**Eligibility Criteria for selection of Empanelled Contractors in KSCC  
for the year 2016-17**

1. The applicant should be a registered A class Government contractor.
2. The applicant should have at least 5 years experience in the field of construction of major building, bridge, road or water supply work etc.
3. The applicant should have satisfactorily completed any of the major building/ water supply works costing Rs. 3 crores or above, or bridge/road work costing Rs. 5 crores or above for a single work during the preceeding three years.
4. The applicant should have good track record in terms of quality of work, workmanship and timely completion etc.
5. The applicant should not be black listed by the Authorities of PWD, KWA, and Irrigation Department or any other Govt. Department.
6. The applicant should have good financial back ground, having an average turnover of 3 crores per year during the last three years.
7. Contractors who have been terminated by KSCC from the execution of works with risk & cost for the last 5 years need not apply for including in the panel.

## **SELECTION PROCEDURE**

On identifying a particular work for execution through notification of tenders in the web sites or Dailies published by Govt. Departments, the empanelled contractors of KSCC may submit their offers (with PQ documents if required) based on the tender schedule in sealed cover, 3 days in advance of last date of submission of the tender, to the concerned General Manager of KSCC (ie EKM/TVM). Such offers received will be opened confidentially and jointly by the Managing Director, KSCC and the concerned General Manager. The rates quoted by the contractors will be entered in the Register kept with the General Managers. A Memorandum of Understanding will be executed by KSCC with the lowest Quoted Contractor. The KSCC will participate in the e-tender of the client department at the rate offered by the MOU holder. The submission fee shall be remitted by the MOU executor. If the work is awarded to KSCC, the MoU executor will be informed immediately from KSCC for execution of formal contract agreement as subcontractor, as expeditiously as possible. All the Tender conditions and agreement with the client department shall be bound to the subcontractor also.
