The responsibility of the architect is :

Preparation of all suitable Architectural Drawings for applying for Work Permit for the work “ **Construction of Transportation Hub at KSRTC, Ernakulam premeises** “ from Kochi Corporation as per the requirements shown below:

1. all statutory requirements should be satisfied.

2. The site plan should demarcate Terminal building and various facilities to be provided as a part of the Transportation Hub.
3. the Terminal building should cater to parking of 25 buses (6 KSRTC and 19 private) in the designated bus bays.
4. the terminal building should have provision for
 - a) kiosks 7 numbers for selling snacks, coffee, newspapers etc
 - b) seating capacity for 125 people waiting buses
 - c) KSRTC ticket booking counter
 - d) KSRTC Enquiry counter

 - g) Adequate Number of toilets for Males and Females
 - h) Overhead tank for water supply

 - k) Public Filtered Drinking Water Points every 40m of Terminal Building
 - l) Electrical Room
 - m) Advertisement Boards (Position and Numbers to be decided on discussion with client)
 - n) ATM Counters – 2 Numbers
 - o) Washbasin counters every 40 m length of Terminal building
 - p) Provision for adequate Public Address System

- q) Medical Shop
 - r) Restaurant – One Number
 - s) Milama Parlour
 - t) Long Distance Bus Ticket Booking Counter
 - u) Security (Police) Room
 - v) Transportation Hub Office Room
5. The site should cater to parking of buses next due for scheduled trips
 6. the site should have parking facility for long distance buses
 7. site should have designated autorickshaw parking area
 8. site should have adequate parking space for two wheelers and four wheelers as per statutes applicable.
 9. the site should have facility for washing of buses
