4	Brief Description of Work	The proposal is for the Construction of New OP Block and Upgradation Works at GHD Uppukunnu in Idukki District. The proposed area comes to 51.10 SQM. The building is designed as per the requirements of NAM authorities and Head of concerned Institutions. It consists of Consultation Room, Waiting Area, Feeding Room and Toilet. These are essential for the proper functioning of the existing hospital. The proposed building is in framed structures with foundation for G+1 as per the direction of authorities. Foundation, column, plinth beam, main beams, GF-slab etc are proposed in RCC M25 concrete and lintel & sunshade in RCC M20 concrete mix. Superstructure is proposed with CC solid blocks, Aluminum doors, windows and ventilators with MS grill, GI truss work in first floor. All the external surface and internal surfaces of the newly constructed wall shall be plastered with 12 mm thick cement plaster 1:4, painting with emulsion and enamel paint, flooring with vitrified and ceramic tile etc. are proposed in this estimate. All the required finishing works are included in the estimate. The estimate has been prepared based on DSoR 2021 with cost index @ 144.45 for Idukki District. Total AS amount is 30 Lakhs. The estimate cost comes to Rs 30 Lakhs including G S T 18%, P M C charge @6.09%, Electrification, water supply and sanitary items, cost of fixtures etc.
